
Dental Deficitsfor Medicaid & CHIP enrollees





Benevis' oral evaluation rates exceed the average CMS oral evaluation rate of 46%²

Only 18% of dentists including Benevis treat 100+ children with Medicaid coverage annually, while 67% treat none. Over 80% of Benevis' patients rely on Medicaid or CHIP.



25 mil. people have been <u>disenrolled</u> from Medicaid due to the unwinding of continuous




9 states offer adults emergency dental care only or no coverage at all through Medicaid⁴

In 2023, about 1/3 of Medicaid and Medicare participants had no dental coverage.⁵

38% of children ages 0-18 have dental benefits through Medicaid or CHIP⁶

Nearly <u>half</u> of Medicaid or CHIP enrolled children 0-18 visited a dentist in the past year⁶

Average Medicaid fee-for-service dental reimbursement <u>rate</u> is 39.2% for children and 29.9% for adults⁴

Inconsistent Medicaid Reimbursement Complicates Dental Access

On top of social and economic factors, limited dentist participation in Medicaid and CHIP presents another big barrier to dental care. Including Benevis, only 18% of dentists in the U.S. treat 100 or more children covered by Medicaid or CHIP plans each year. For the underserved, difficulty finding dental providers can lead to neglected oral health and greater problems and costs later.

Almost <u>22%</u> of 19 to 64-year-old adults in the U.S. had no dental insurance⁶



Nearly <u>17%</u> of 19 to 64-year-old U.S. adults went without dental care for 12 months due to cost ⁶

Dental care services carry more significant cost barriers than any other type of healthcare services.⁶



58% of adults believe dental insurance is unaffordable



Almost 3X the number of adults have no dental insurance vs. no health insurance

86% of adults believe having dental insurance is critical to maintaining oral health and overall health.

<u>More</u> adults visit the dentist with insurance coverage⁸



<u>Fewer</u> adults visit the dentist without insurance coverage⁸



Hispanic adults <u>two</u> times more likely to lose dental insurance ⁷





88% of adults say having dental insurance makes them worry less in an emergency 8
